



## FICP FLAT-RATE CORPORATE MEMBERSHIP

FICP is pleased to continue the flat-rate corporate membership structure in 2012. For an annual fee of \$2,000 USD, planner member companies can include an unlimited number of planner memberships for their firm. This includes additional planners that are hired by the firm during the year.

For example, if a firm currently has 11 planner members who pay dues, the collective payment would equal \$2,200 (11 members x \$200). Under the new structure, the firm could elect to pay a flat \$2,000 and include all 11 planner members, plus any additional planners from the firm.

FICP will continue to offer a \$50 discount on each individual's membership dues for those companies with five or more members. This discount is automatically applied to qualifying planner member dues invoices.
